### **Delivery Method**

The Faculty of Educational Leadership will deliver a **majority** of coursework leading to the M.S. degree primarily by distance delivery. Distance delivery means a combination of **two-way"video/audio** delivered to multiple geographic sites and/or by **web-based** instruction. Short periods of concentrated study on the K-State campus are required in most cases— whenever appropriate, K-State faculty will also travel to central locations for **face-to-face** interaction. For general definition purposes, any course regarded as distance-delivered will be comprised of **at"least"2/3** electronic interface.

Emphases are available in **Adult"Education** or **Educational"Adminis-tration**, with additional flexibility to construct personalized programs of study relating to the aspirant's specific interests.

Educators holding goals in the following program emphases may especially benefit:

#### **Adult Education**

- Human resource managers/trainers
- Business/industry/nonprofit executives
- Community college professionals
- University Cooperative Extension
- Armed service professionals

#### **Educational Administration**

- Building leadership aspirants
- District leadership aspirants
- Central office leadership aspirants
- Community college administration aspirants

#### **Other Flexible Designs**

Programs of study may also be individualized to provide graduate-level leadership training to enhance other career goals. Examples include combining broad leadership skills with other academic content areas and may potentially include combinations with existing graduate certificates in addition to formal degree pursuit. On a limited scale, some aspects of doctoral programming may be augmented via this distance delivery initiative.

### **General Degree Requirements**

Master's degrees (MS) in the Department of Educational Leadership are available in Adult Education (EDACE) and Educational Administration (EDADL). The MS requires a minimum 30 semester hours of approved coursework. More coursework is required if professional licensure is involved. Sample MS programs incorporating distance delivery are shown in this brochure.

Doctoral degrees in the Department of Educational Leadership are available in Adult Education (EdD/PhD) and in Educational Administration (EdD). All doctoral degrees require at least 90 semester hours at the graduate level. Some parts may be completed via distance.

Programming is also available for non-degree seekers such as district-level licensure in which a large part of coursework may be done off-campus in individualized fashion.
